

## **The constitution of the Students' Union UCL ART BUSINESS SOCIETY**

### **1 Name**

- 1.1 The name of the society shall be the Students' Union UCL **Art Business Society**.
- 1.2 The society shall be affiliated to Students' Union UCL.

### **2 Statement of Intent**

- 2.1 The constitution, regulations, management and conduct of the society shall abide by all Students' Union UCL Policy, and shall be bound by the Students' Union UCL Memorandum and Articles of Association and Byelaws, the Club and Society Regulations and the Club and Society Procedures and Guidance, laid out in "how to guides".
- 2.2 The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to management of the club/society shall not contravene this policy.

#### President

3.5.9 External Relations Officer: Contacts external parties outside of UCL who work in the sector

3.5.10 Welfare Officer: Ensures experiences are safe and comfortable, communicates and promotes welfare needs to the President, the Union and UCL.

- 3.6 Management of the club/society shall be vested in the club/society committee which shall endeavour to meet regularly during term time (excluding college reading weeks) to organise and evaluate the club/society activities.
- 3.7 The committee members will perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.
- 3.8 Committee members are elected to represent the interests and well-being of club/society members and are able to be held to account. If club/society members are not satisfied by the performance of their representative officers they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

#### 4 Terms, Aims and Objectives

4.1 The club/society shall hold the following as its aims and objectives:

4.1.1 To combine the disciplines of Art History and Business in a way that will provide new experiences for students. This includes introducing them to new branches in the art world, providing networking opportunities, and creating a space and peer group of colleagues with common interests and goals

4.2 The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.

4.3 The core activities of the society shall be:

4.3.1 Hosting speakers that relate to, but are not restricted to, art, art history, and art business

4.3.2 Hosting networking events relating to, but not restricted to, art, art history, and art business

4.3.3 Hosting debates and panel discussions on topics relating to, but not restricted to, art, art history, and art business

4.3.4 Tours of Art Institutions (this includes but is not restricted to galleries, museums and auction houses)

4.4 In addition, the club/society shall also strive to organise other activities for its members where possible:

4.4.1 Organizing and hosting art exhibitions and/or auctions

4.4.2 Socials

4.5 This constitution shall be binding on the club/society officers and shall only be altered by consent of two-thirds majority of the full members present at a society general meeting. Activities Network Executive shall approve any such alterations.

4.6 This constitution has been approved and accepted as the Constitution for the Students' Union UCL Art Business Society. By signing this document the President and Treasurer have declared that they have read and abide by the Students' Union UCL Clubs and Societies Regulations.
