

# The Constitution of Students' Union UCL

## YOGA AND MEDITATION CLUB

### 1 Name

- 1.1 The name of the club/society shall be Students' Union UCL Yoga and Meditation Club.
- 1.2 The club/society shall be affiliated to Students' Union UCL.

### 2 Statement of Intent

- 2.1 The constitution, regulations, management and conduct of the club/society shall abide by all Students' Union UCL policy, and shall be bound by the [Students' Union UCL Memorandum & Articles of Association](#), [Byelaws](#), [Club and Society Regulations](#) and the club and society procedures and guidance – laid out in the '[how to guides](#)'.
- 2.2 The club/society stresses that it abides by Students' Union UCL Equal Opportunities Policies, and that club/society regulations pertaining to membership of the club/society or election to the club/society shall not contravene this policy.

### 3 The Society Committee

#### President

- 3.1 The president's primary role is laid out in section 5.7 of the Club and Society Regulations.

#### Treasurer

- 3.2 The treasurer's primary role is laid out in section 5.8 of the Club and Society Regulations.

#### Welfare Officer

3.3 The welfare officer's primary role is laid out in section 5.9 of the Club and Society Regulations.

## Additional Committee Members

### Project Manager

3.4 The Project Manager's primary role is to organise a trip or retreat for the Club's members and to take care of all issues regarding merchandise. Additionally, the Project Manager is expected to take on further responsibility regarding the organisation and execution of any plans made for events and workshops.

### Communications Officer

3.5 The Communications Officer's primary role is to ensure good communication with the Club's members. This includes but is not limited to communication via email and our website.

### Social Media Secretary

3.6 The Social Media Secretary's primary role is to ensure good communication with the Club's members through all social media channels such as Facebook and Instagram.

### Social Events Secretary

3.7 The Social Events Secretary's primary role is to initiate and organise social events for the Club's members

3.8 Management of the club/society shall be vested in the club/society committee which will endeavour to meet regularly during term time (excluding UCL reading weeks) to organise and evaluate club/society activities.



3.9 The committee members shall perform the roles as described in section 5 of the Students' Union UCL Club and Society Regulations.

3.10 Committee members are elected to represent the interests and well-being of club/society members and are accountable to their members. If club/society members are not satisfied by the performance of their representative officers they may call for a motion of no-confidence in line with the Students' Union UCL Club and Society Regulations.

## 4 Terms, Aims and Objectives

4.1 The club/society shall hold the following as its aims and objectives.

- 4.2 The club/society shall strive to fulfil these aims and objectives in the course of the academic year as its commitment to its membership.
- 4.3 The core activities of the club/society shall be:
- 4.3.1 Regular daily yoga classes during term-time, including college reading weeks.
- 4.3.2 Regular monthly social events.
- 4.4 In addition, the club/society shall also strive to organise other activities for its members where possible:
- 4.4.1 One domestic and one international retreat
- 4.5 Additional special classes and workshops
- 4.6 This constitution shall be binding on the club/society officers, and shall only be altered by consent of two-thirds majority of the full members present at a club/society general meeting. The Activities Zone shall approve any such alterations.
- 4.7 This constitution has been approved and accepted as the Constitution for the Students' Union UCL Yoga and Meditation Club. By signing this document the president and treasurer have declared that they have read and abide by the Students' Union UCL Club and Society Regulations.
